27. I understand I could have a hearing in person before a court in order to grant a divorce under Wis Stat. §767.235 and 767.315. I am hereby waiving that right and wish to not have an in-person hearing. I am also waiving my right to appeal this waiver. I have discussed this waiver and Wis Stat. §767.235 and 767. with my attorney and he/she has answered all of my questions. I ask the court to waive a final divorce hearing based upon a finding of good cause due to the public health emergency caused by COVID-19.
28. No one has forced me to sign the Marital Settlement Agreement. I signed it out of my own free will.
29. No one has forced me to give up my right to an in-person hearing. I am giving it up out of my own free will.
30. I am satisfied with my attorney's representation.
31. I understand that I am unable to remarry until six (6) months from date of the granting of the divorce by the court. I understand that any such marriage prior to six (6) months from the date of the granting of divorce by the court is null and void.

I understand that the date of the granting of divorce will likely be later than the date I am signing this affidavit.
